

Opinion


We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and communicate to them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Other Matter

- (9) The Statement includes the results for the quarter ended 31-March-2024, being the balancing figures between the audited figures in respect of the full financial year and the published audited year- to-date figures up to the third quarter of the current financial year which were subject to limited review by us. Our opinion is not modified in respect of this matter.
- (10) Repair & Maintenance revenue expenses of RS 37,92,410 included in "Other expenses" up to 31-December-2023, have been reversed and capitalized under the head "Furniture & Fixtures" by the same amount in the 4th quarter ended 31-March-2024. Having regard to substantial expenditure incurred with enduring benefits, in future, the management, as a matter of prudence, has decided to the said treatment of transaction. Consequently, quarterly financial figures for the quarter ended 31-March-2024, are not strictly comparable with earlier quarters.
