**Aradhana Investments Limited**



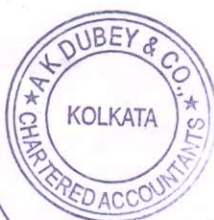
